## ZARA GIFT CARD GENERAL TERMS AND CONDITIONS OF USE

- 1. The Gift Card (hereinafter, the "Card") is the property of the issuer ZARA LUXEMBOURG S.A. (VAT n° LU 16962782/RCS n° B0049966) having its registered office at 22, Grand-Rue, 1660 LUXEMBOURG (hereinafter, ZARA), the holder of the Card being a mere depositary.
- 2. The Card is available for sale in the following formats:
  - 2.1 Physical Card at any ZARA's points of sale located in Luxembourg (hereinafter, "ZARA stores").
  - 2.2 Physical Card via the ZARA website for Luxembourg (hereinafter, "www.zara.com").
  - 2.3 Virtual Card on www.zara.com.

Sale of the above Card's formats shall be subject to availability in Luxembourg.

- 3. The Card is exclusively valid in Luxembourg to purchase products being sold in any ZARA store in or via www.zara.com.
- 4. The price of the Card can be paid by any of the means of payment accepted at the ZARA stores or on www.zara.com. The Card shall not be paid by means of another Card.
- 5. Any outstanding balance of the Card shall not be refunded, or exchanged for cash. Notwithstanding the above, the return of any Card which has not been used yet shall be accepted without indemnity or indication of any reason and according to the following terms:
  - 5.1 Physical Cards purchased at any ZARA store may be returned within thirty (30) calendar days as of the day after the date of the purchase of the Card.
  - 5.2 Physical Cards purchased via www.zara.com may be returned within thirty (30) calendar days as of the day after the date of the shipping confirmation e-mail.
  - 5.3 Virtual Cards purchased via www.zara.com may be returned within thirty (30) calendar days as of the day after the date of dispatch by e-mail of the virtual Card to the intended recipient thereof.

The price paid for the Card shall be refunded using the same means of payment used to purchase it. For such refund, the original sales receipt or the E-ticket and, where appropriate, the payment card and the payment receipt must be presented. The E-ticket is attached to the shipping confirmation e-mail, and also saved under your account on www.zara.com, and on the mobile App. Return of any Card purchased abroad or on www.zara.com website of any other country shall not be accepted.

- 6. The Card can be used as often as the holder thereof would like, until the total amount has been used up.
- 7. The remaining balance on the Card available shall be the difference between the remaining balance available prior to the purchase, and the relevant amount used up in such purchase. Where the purchase price is in excess of the remaining balance on the

Card, the difference may be paid through any payment means accepted at any ZARA store or on www.zara.com, as the case may be.

- 8. The remaining balance on the Card is shown on the cash register receipt every time a purchase is made with the Card, for purchases made at any ZARA store, or in the information provided upon placing an order, for purchases made via www.zara.com. The remaining balance of the Card may be checked at any ZARA store or on www.zara.com.
- 9. Products purchased with the Card at any ZARA store shall be subject to the general purchase terms and conditions as any other products purchased at said stores. Products purchased with the Card via www.zara.com shall be subject to the purchase terms and conditions shown on www.zara.com.
- 10. Where appropriate, refund for products purchased with the Card which are returned shall be made by ZARA by crediting the price of the returned product back onto the remaining balance of the Card or where the Card no longer exists upon the return of the products, by crediting the price of the returned product to a Voucher Card issued by ZARA (i) to be handed out in the store, for any refund for products purchased at any ZARA store or (ii) to be sent by e-mail, to the e-mail address of the customer who made the purchase with the Card, for any return of products purchased via www.zara.com.

Refund methods hereunder provided are an essential term, and as such, they are deemed to be expressly accepted upon purchasing and/or using the Card.

- 11. The Card is valid for 3 years from the date of (i) purchase at any ZARA store of the physical Card, (ii) shipping confirmation e-mail of the physical Card bought on www.zara.com or (iii) dispatch of the virtual Card by e-mail to the intended recipient thereof. At the expiry of the validity period, the Card cannot be renewed, or used to purchase goods, nor shall any unused remaining balance in the Card be claimed.
- 12. The Card is a bearer instrument. Its holder shall be solely responsible for the use and custody of the Card. The Card shall not be replaced in case of theft, loss or damage thereof. However, ZARA reserves its right to replace the Card in case of change of format of it.
- 13. Where the virtual Card is purchased via www.zara.com, ZARA shall not be responsible for the non receipt or the delay in receiving such Card by its intended recipient on grounds beyond ZARA's control, including inter alia: (i) the deficiencies or the breakdown of telecommunications lines/systems, (ii) the delay in the transmission of information or data or the loss of information or data which may occur under any of the circumstances provided under letter (i) above; (iii) the inaccuracy of the details of the recipient of the virtual Card provided by the purchaser of the Card; (iv) the non delivery of the Card at the e-mail address provided, or (v) the fact that the e-mail sent by ZARA is deemed to be spam or unwanted e-mail.
- 14. Cards originally obtained through any unlawful means shall be null and void and they shall not be used to purchase products, nor shall the price thereof be refunded.
- 15. The Card shall not be used for the purposes of advertising or promoting products or services marketed by any third party other that the issuer of the Card, unless prior written consent is given by this latter.

- 16. The purchase/ use of the Card entails the full acceptance of these terms and conditions which have been made available to the customer upon purchase of the Card, and which are also available at any ZARA store and on www.zara.com.
- 17. The purchase/ use of the Card shall be governed by Luxembourg law. Any controversy that arises or is related to the purchase/ use of the Card shall be subject to the exclusive jurisdiction of the Luxembourg courts.
