PRIVACY POLICY AND COOKIES ZARA

- 1. Every time you use this website, you will be bound by the then current Privacy Policy and you should review this text every time you use the website to be sure you agree with it.
- 2. Personal data you provide us with will be processed and stored in a file under the responsibility of ZA GİYİM İTHALAT İHRACAT VE TİCARET LİMİTED ŞİRKETİ ("ZARA") for the purposes of:
 - I. The development, performance and enforcement of the purchase and sale contract over the products you have purchased, or of any other contract between you and us;
 - II. attending to your requests; If you decide to use the WhatsApp customer service channel, where available on our app by clicking the access button, it also entails that if you have the WhatsApp app installed in your device, and you acknowledge and agree that ZARA will transfer your mobile/cellular phone number to WhatsApp Inc. to verify if your number relates to a current user of the WhatsApp platform. Such verification service described above includes transmitting data back to Us so you can use this channel. ZARA stores and transmits data in accordance with the principal international confidentiality and security standards for credit and debit cards. The use of this feature may require the modification of your password for security reasons. Please remember that security when using the website also depends on the correct use and conservation of certain sensitive codes.
