- 1. Every time You use this website You will be bound by the then current Privacy Statement and You should review this text every time You use the website to verify that You agree with it.
- 2. You will be requested to provide and the legal entity named ITX TAIWAN B.V. ZARA TAIWAN BRANCH ("ZARA") will collect your personal data, including your first and last name, email address, telephone number, delivery address and post code, etc. ("Personal Data"), during your creation of account in this website and/or your purchase of product through this website or other interactions with You in which this Privacy Statement may apply due to fact that ZARA may collect Personal Data whether in person in ZARA stores or through your use of the ZARA.COM website and co-branded versions of the website located at URLs that point to the domain name ZARA.COM (the "Website" or "Site").
- 3. Personal Data you have provided will be process confidentially and will now become part of a database file property of ZARA. These data of a personal nature will be used by ZARA and other company in Inditex Group exclusively for the following purposes:
 - 1. the fully performance and enforcement of the purchase and sale contract over the products You have purchased, or of any other contract between us;
 - 2. attending to Your requests;
 - 3. providing You with information about the marketing activity and/or products of Zara or of any other brands belonging to the Inditex Group (whose objects are related to the e-commerce, decoration, textile, finished fashion and homeware products sectors, and to any other objects supplemental to the above, including cosmetics and leather goods), including, as regards the above referred products, sending commercial communications by e-mail to your email address or by any other equivalent electronic communication means (such as SMS) as well as phone calls. You can change your preference in respect of receiving such information by logging into the MY ACCOUNT section of this website and editing your preferences. You can unsubscribe at any time at the Newsletter section;
 - 4. in the event that you have a Gift Voucher and you wish to return the goods associated with it via the website, we will use the personal details provided by you on the return form only for (a) managing the request and processing the door to door collection of goods, (b) meeting any requests related to the Gift Voucher or the return that you request, and (c) confirming acceptance of the return and then sending the Store Credit Card with the refund amount via email or other equivalent electronic means;
