### **GENERAL TERMS AND CONDITIONS OF PURCHASE AND USE**

### 1. INTRODUCTION

This document (together with the documents mentioned herein) establishes the general terms and conditions that govern the use of this website www.zara.com and the purchase of product(s) on it (hereinafter referred to as the "Conditions").

We urge you to read the Conditions, our Cookies Policy and our Privacy Policy (hereinafter, jointly, the "Data Protection Policies") carefully before using this website. When using this website or placing an order on it, you are bound by these Conditions and our Data Protection Policies. If you don't agree with the Conditions and with the Data Protection Policies, do not use this website.

These Conditions may be modified. It is your responsibility to read them periodically, as the Conditions at the time of using the website or concluding of the relevant Contract (as defined further on) shall be those that apply. These Conditions can be downloaded at any time in pdf. format from this website.

If you have any query regarding the Conditions or the Data Protection Policies, you may contact us by using the contact form.

The Contract (as defined below) may be executed, at your choice, in any of the languages in which the Conditions are available on this website.

#### 2. OUR DETAILS

## 3. YOUR DETAILS AND YOUR VISITS TO THIS WEBSITE

Its information obligation to the consumer within the meaning of Article 13 of Regulation No. 2016/679 (General Data Protection Regulation - GDPR) relating to the processing of the consumer's personal data for the purposes of fulfilling the purchase contract, for the purposes of negotiation of the purchase contract, for the purposes of fulfilling the interests of the Seller laid down by laws and for the marketing purposes, is fulfilled by the Seller through a separate document - the Data Protection Policies.

The information or personal details that you voluntarily provide us shall be processed in accordance with the above stated legal regulation and the Data Protection Policies.

Before using any of our services or functionalities available, particularly in respect of processing the order form and other relevant activities relating to the purchase of product(s), please read carefully the information about the personal data processing - Privacy Policy.

### 4. USE OF OUR WEBSITE

When you use this website and place orders through it, you agree to:

- i. Use this website to make enquiries and legally valid orders only.
- ii. Not to make any false or fraudulent orders. If an order of this type may reasonably be considered to have been placed, we shall be authorised to cancel it and inform the competent authorities.
- iii. Provide us with your email address, postal address and/or other contact details truthfully and exactly. You also agree that we may use this information to contact you in the context of your order if necessary (see our Privacy Policy).

If you do not provide us with all the information we need, you cannot place your order.

When you place an order on this website, you state that you are over the age of 18 and are legally eligible to enter into binding contracts.

Please be informed that we reserve the right to prevent you from accessing our website and/or one or more of the functionalities we offer on this website, or to delete your account, if your behavior constitutes a breach of these Conditions and/or any applicable law or if we have reasonable grounds to believe that you are making fraudulent use of our website and/or any of the functionalities we offer or when you abuse your rights to the detriment of our business.

#### 5. SERVICE AVAILABILITY

Delivery service for the articles offered on this website is available in the Czech Republic only.

If you wish to order products from another EU member state outside of the Czech Republic via this website you are of course welcome to do so; however, the ordered product(s) can only be delivered to a ZARA and/or Zara Home (but only in case of Zara Home products, NOT for ZARA products) shop in the Czech Republic or a delivery address within the Czech Republic.

## 6. FORMALISING THE CONTRACT, STORAGE AND ACCESSIBILITY OF THE ELECTRONIC DOCUMENTS

#### 6.1. General information

The information contained in these Conditions and the details contained on this website do not constitute an offer of sale, but rather an invitation to enter into a contract. There shall be no contract between you and us in relation to any product until your order has been expressly accepted by us. If your offer is not accepted and your account has already been charged, you shall be reimbursed in full.

To place an order, you must follow the online purchasing procedure and click on "Confirm payment". After doing so, you will receive an email confirming receipt of your order (the "Order Confirmation"). This does not mean that your order has been accepted. Your order is an offer that you are making to us to buy one or more products. All orders are subject to our acceptance. You will be informed of our acceptance via email in which we will confirm that the order is being sent (the "Delivery Confirmation"). The contract (the "Contract") is concluded only when we send you the Delivery Confirmation.

A summary of the details of your order will be attached to the Delivery Confirmation ("e-ticket").

### 6.2 Storage and accessibility of the electronic documents in which the purchase is formalised

If you are a registered user you will have, in addition to the Delivery Confirmation sent to you, a record of each transaction made in the "My Account" section for a period of three years, which includes access to the invoice and purchase receipt corresponding to each transaction. After these three years, you can contact our customer service, through any of the means made available to you.

If you are not a registered user or have any questions in this regard, you can contact - in addition to the Delivery Confirmation sent to you - our customer service through any of the means referred to above.

### 7. AVAILABILITY OF PRODUCTS

All product orders are subject to availability. Along this line, if there are difficulties regarding the supply of products or there are no more items left in stock, we reserve the right to provide you with information on substitute products of the same or higher quality and value that you may order. If you do not wish to order the substitute products, we will reimburse any amount that you may have paid.

## 8. REFUSAL TO PROCESS AN ORDER

We reserve the right to remove any product from this website at any time and to remove or modify any material or content from the same. Although we will always do everything possible to process all orders, there may be exceptional circumstances that force us to refuse to process an order after having sent the Order Confirmation. We reserve the right to do so at any time.

We shall not be liable to you or to any third party for removing any product from this website, or for removing or modifying any material or content from the website or not processing an order once we have sent the Order Confirmation.

## 9. DELIVERY

The available delivery methods, the associated quantities and any other relevant information are described in our Shopping Guide (see the section on Delivery).

Notwithstanding Clause 7 above regarding product availability and except for extraordinary circumstances, we will endeavor to send the order consisting of the product(s) listed in each Delivery Confirmation prior to the date indicated in the Delivery Confirmation in question or, if no delivery date is specified, in the estimated timeframe indicated when selecting the delivery method and, in any case within a maximum period of 30 days from the date of the Order Confirmation.

Nonetheless, there may be delays for reasons such as the occurrence of unforeseen circumstances or the delivery zone.

As for the virtual gift card (hereinafter referred to as "eCard"), we will deliver it on the date indicated by you when placing the order.

If for any reason we are unable to comply with the delivery date, we will inform you of that situation and we will give you the option to continue with the purchase, establishing a new delivery date, or cancel the order with full reimbursement of the amount paid. Keep in mind in any case that we do not make home

deliveries on Saturdays, Sundays or bank holidays, except in the case of the eCard which will be delivered on the date specified by you.

For the purpose of these Conditions, the "delivery" shall be understood to have taken place or the order "delivered" as soon as you or a third party indicated by you acquires physical possession of the goods, which will be evidenced by the signing of the receipt of the order at the delivery address indicated.

The eCard will be considered delivered as set out in the Terms of Use of the Gift Card and, in any case, at the time of sending this to the email address specified by you.

### **10. INABILITY TO DELIVER**

If it is impossible for us to deliver your order, we will attempt to find a safe place to leave it. If we cannot find a safe place, your order will be returned to our warehouse. We will also leave a note explaining where your order is located and what to do to have it delivered again. If you will not be at the place of delivery at the agreed time, we ask you to contact us to organize delivery on another day.

If after 30 days from the date your order is available for delivery, the order could not be delivered for reasons not attributable to us, we shall assume that you wish to cancel the Contract and it will be terminated. As a result of the termination of the Contract, we will return to you all payments received from you, including delivery charges (except for any additional charges resulting from your choice of any delivery method other than the ordinary delivery method that we offer) without any undue delay, and at any rate, within 14 days of the date on which this Contract has been terminated.

Please keep in mind that transport derived from the termination of the Contract may have an additional cost which we will be entitled to pass on to you.

This clause does not apply to the eCard, whose delivery is governed by the provisions of the Terms of Use of the Gift Card and the provisions of Clause 9 above.

## 11. TRANSMISSION OF RISK AND OWNERSHIP OF THE PRODUCTS

The products shall be under your responsibility from the moment of delivery to you as outlined in Clause 9 above.

You will take ownership of the products when we receive full payment of all amounts due, including delivery charges, or at the moment of delivery (as defined in Clause 9 above), if that were to take place at a later time.

# 12. PRICE AND PAYMENT

### 12.1 General Information

The price of the product(s) will be as stipulated at all times on our website, except in the case of an obvious error. Although we make every effort to ensure that the prices featured on the website are correct, error may occur. If we discover an error in the price of any of the products that you have ordered, we will inform you as soon as possible and give you the option of confirming your order at the correct price or cancelling it. If we are unable to contact you, the order will be considered cancelled and all amounts paid will be

reimbursed to you in full without undue delay and no later than 14 days after the date of termination of this Contract.

We are not obliged to provide you with any product at the incorrect lower price (even when we have sent the Delivery Confirmation) if the error in the price is obvious and unmistakable and could have reasonably been recognized by you as an incorrect price. If it is a case, we will offer the consumer the opportunity to purchase the product at the correct price or to cancel the order.

The prices on the website include VAT, but exclude delivery charges, which are added to the total price as indicated in our Shopping Guide (see the section on Delivery Charges).

Prices may change at any time. However, except as stipulated above, the changes shall not affect the orders for which we have sent an Order Confirmation. The prices of products are those which apply at the time of consumer's order.

Once you have selected all articles that you wish to buy, they will be added to your Shopping Bag. The next step will be to process the order and make the payment. To that end, you must follow the steps of the purchase process, indicating or verifying the information requested in each step. Furthermore, throughout the purchase process, before payment, you can modify the details of your order. You are provided with a detailed description of the purchase process in the Shopping Guide. Also, if you are a registered user, a record of all the orders placed by you is available in "My Account" section.

You can use the following cards and methods as payment method: Visa, MasterCard, American Express, Visa Electron, Apple Pay and PayPal. You can also use a gift card, an eCard or a voucher card issued by Inditex Česká republika, s.r.o. for the Czech Republic to pay all or part of the purchase price.

Please note that the option "Change of size" will only be available for ZARA products (NOT for Zara Home products) and when the following means of payment are used: American Express, Visa and MasterCard.

To minimise the risk of non-authorised access, your payment credit card details will be encrypted. Once we receive your order, we request a pre-authorization on your card to ensure that there are sufficient funds to complete the transaction. The charge on your card will be made at the time your order leaves our warehouse.

If your payment method is PayPal, the charge will be made when we confirm your order.

When you click "Confirm payment", you are confirming that the payment card is yours or you are the rightful holder of the gift card / eCard or the voucher card.

Payment cards are subject to verification and authorisation by the card issuing entity. If the entity does not authorise the payment, we shall not be liable for any delay or failure to deliver and we will be unable to conclude any Contract with you.

Under the Czech Electronic Records of Sales Act, the Seller is required to issue an invoice to the buyer/consumer; at the same time, it is required to register online the received revenue with the tax administrator.

We use electronical invoices. Herewith you agree that you receive invoices electronically. Electronical invoices will be made available to you in PDF format under "My Account" on this website. We will inform

you for each purchase in the Delivery Confirmation if the electronical invoice is available.

Please be informed that Fashion Retail, S.A. with corporate seat at Avenida de la Diputación, Edificio Inditex, Arteixo, A Coruña (Spain), registered in the commercial register of A Coruña, vol. 3425, page 49, C-47731, 1st entry, and tax identification number A-70301981 will collect and make refunds on behalf of the Inditex Česká republika, s.r.o. in relation to all payments made through this website.

### 12.2 Ordering with the help of electronic devices

If you are placing your order through one of the electronic devices that are available at certain stores in the Czech Republic for this purpose, you must follow the steps of the purchase process that appear on the device, completing or verifying the information requested in each step. Throughout the purchase process, before payment, you can modify the details of your order. You must choose your payment method, and whether or not you require a gift receipt (if one is available), before you place your order. Please note that a binding order is placed at the time that you press the relevant "Confirm payment" button on the device screen, and you are required to pay for your order once it has been placed.

Payment can be made by Visa, MasterCard, or American Express, and the above provisions regarding validation checks and authorisation of your card will apply. You may also be given option to pay at the till in which case your payment can be made by any of the means of payment available in those stores.

Please note that if you place your order through an instore electronic device in the Czech Republic, but wish to cancel the order, you must pay for the order and wait for the items to be delivered, before returning them in accordance with the returns policy described below (withdrawal from the contact).

## 13. BUYING GOODS AS A GUEST

The functionality of buying goods as a guest is also available on the website. Under this type of purchase, only *such data which are essential* to process your order will be requested from you. Upon completion of the purchase process, you will be offered the possibility of registering as a user or continuing as a non-registered user.

#### 14. EXPRESS CHECKOUT

The express checkout (hereinafter "Express Checkout") makes it easier for you to make purchases on this website as you do not have to enter shipping, billing and payment information for each purchase. Express Checkout is available in the "Shopping Bag" section.

To use Express Checkout you will have to save your payment card information. You may do so when making a payment with any of the cards accepted by this website by clicking the "Save my card details" option.

This will result in the following payment card details being saved: card number, card holder name exactly as it appears on the card and card expiry date.

To save your card information and use Express Checkout, you have to accept the applicable Privacy Policy.

By agreeing to use Express Checkout, you authorise that purchases paid though the tool be charged to the respective card linked to the tool. Card usage shall be governed by the written terms between you and the card issuer in all cases.

You may save card information in Express Checkout for as many cards as you like, to do so you must make at least one payment with each of them. If you wish to save card information for more than one card, the card whose information was saved most recently will be considered your "Favorite Card", and will be charged for Express Checkout purchases by default. However, you may change your Favorite Card in the "My Account" section of this webpage.

To use Express Checkout, you only have to click on the "Express Checkout" button that appears in the Shopping Bag. A screen will immediately appear with the shipping, billing and payment information for your purchase. The information available on this screen cannot be edited, so if there is incorrect information do not complete the purchase. To make purchases using different details please do not use the Express Checkout service.

You may change your Favorite Card linked to Express Checkout in the "My Account" section of this webpage.

The provisions of this clause shall not apply if you buy goods as a guest.

#### **15. VALUE ADDED TAX**

Pursuant to the prevailing rules and regulations in force, all purchases done through the website are subject to the Value Added Tax (VAT).

## 16. EXCHANGE/RETURN POLICY

## 16.1 Statutory right of withdrawal

## Right of withdrawal

If you are contracting as a consumer, you have the right to withdraw from the Contract, within 14 days, without giving any reason, except the products mentioned in Clause 16.3 below, for which the right to withdraw is excluded.

The withdrawal period will expire after 14 days from the day on which you acquire, or a third party other than the carrier and indicated by you acquires, physical possession of the product(s) or in case of multiple product(s) in one order delivered separately, after 14 days from the day on which you acquire, or a third party other than the carrier indicated by you acquires, physical possession of last product ordered in one order.

To exercise the right of withdrawal, you may notify us, under the address Inditex Česká republika, s.r.o., Rybná 682/14, 110 00 Prague 1, by sending an email to info-cz@zara.com, via the "Returns" section of "My account" on this website or by writing to our contact form, of your decision to withdraw from this contract by an unequivocal statement (sent by post or by e-mail) with order details (including order number and the description of the product(s) which are being returned). You may use the model withdrawal form as set out in the Annex, but it is not obligatory.

To meet the withdrawal deadline, it is sufficient for you to send your communication concerning your exercise of the right of withdrawal before the withdrawal period has expired (the notification does not have to be delivered or the products returned to us within this deadline).

## Effects of withdrawal

If you decide to withdraw from this Contract, we will return to you the full price of the product(s) and all other payments received from you in relation to the Contract (less return costs, if applicable, see Clause 16.3), including delivery charges to the original delivery place (except for any additional charges resulting from your choice of any delivery method other than the ordinary delivery method that we offer) without any undue delay, and at any rate, within 14 days of the date on which this Contract has been terminated. We will carry out such reimbursement using the same means of payment as you used for the initial transaction. In any event, you will not incur any charges as result of such reimbursement. Notwithstanding the foregoing, we may withhold reimbursement until we have received the product(s) back or you have supplied evidence of having sent back the product(s), whichever is the earliest.

## - Zara products:

You shall send back the product(s) or hand them over to us at any ZARA store in the Czech Republic without undue delay and in any event not later than on the first weekday after 14 days from the day on which you communicate your withdrawal from this Contract to us. The deadline is met if you send back the product(s) or supplied evidence of having done so before the period of 14 days has expired.

## - Zara Home products:

You shall send back the product(s) or hand them over to us at any ZARA or Zara Home store in the Czech Republic without undue delay and in any event not later than on the first weekday after 14 days from the day on which you communicate your withdrawal from this Contract to us. The deadline is met if you send back the product(s) / supplied evidence of having done so before the period of 14 days has expired.

You are only liable for any diminished value of the product(s) resulting from handling other than what is necessary to establish the nature, characteristics and functioning of the product(s).

## 16.2 Contractual right of withdrawal

In addition to the statutory right to withdraw for consumers, mentioned in Clause 16.1 above, we grant you a period of 30 days from the date of the Delivery Confirmation to return the products (except the products mentioned in Clause 16.3 below, for which the right to withdraw is excluded).

The period of this contractual right of withdrawal shall only be deemed to have been complied with if we have received the respective product(s) within 30 days from receipt of the Delivery Confirmation. If we receive the product(s) after this 30-day period, the contractual right of withdrawal no longer exists and we will return the respective product(s) to you. Your statutory rights shall remain unaffected by this.

The return of the gift card / eCard is also governed by the Terms of Use of the Gift Card.

In case you return the product(s) within the contractual term of the right of withdrawal after the statutory period (14 days) has expired, you will only be reimbursed (less return costs, if applicable, see Clause 16.3) with the amount paid for said product(s). Delivery charges will not be reimbursed.

You may exercise your contractual right of withdrawal in accordance with the provision of Clause 16.1 above. However, should you inform us about your intention of withdrawing from the Contract after the legal term for withdrawal (14 days), you shall, in any case, hand the product(s) over to us (this means receipt of the respective product(s) by us) within the 30 day term as from the Delivery Confirmation. Your right to withdraw from the Contract shall apply exclusively to the product(s) that is (are) returned in the same condition in which you received them. No reimbursement will be made if the product(s) has (have) been used once it has (they have) been opened, for product(s) that is not (are not) in the same condition as when it was (they were) delivered or if it has (they have) been damaged, so take care of the products(s) while in your possession.

## **16.3 Common provisions**

You shall not have the right to withdraw from the Contract when it is for the delivery of any of the following Products:

- i. Customised items
- ii. Music CDs/DVDs without their original wrapping.
- iii. Sealed goods which are not suitable for return due to hygiene reasons and where unsealed after delivery.

Please return the product(s), if possible, by using or including all their original packaging. In any case, you must return / send the product(s) to be returned together with the e-ticket that was attached to the Delivery Confirmation, which is also saved under your account on our website, and on the mobile app.

The return of the gift card / eCard is also governed by the Terms of Use of the Gift Card.

Upon withdrawal, the respective products shall be returned as follows:

# - Zara products:

# (i) Returns at any ZARA store in the Czech Republic:

You may return all ZARA product(s) to any ZARA store in the Czech Republic which has same section as the product you wish to return belongs to. In such case, you should go to such store and present the product(s) with the e-ticket that was attached to the Delivery Confirmation, which is also saved under your account, and on the mobile app. You can present the e-ticket either by showing it in digital form on your mobile phone, or by bringing to the store a print-out of the e-ticket. This option is free of charge.

"Ordering with the help of electronic devices": Please note that in respect of orders (ordered product(s)) that were originally placed through electronic devices in a ZARA store in the Czech Republic and that were paid for at the till of that store, returns can only take place in any ZARA store in the Czech Republic.

# (ii) Returns by courier:

When returning the ZARA product(s) by courier arranged by us, you should contact us via the "Returns" section of "My account" on this website or by writing to our contact form to arrange for the product(s) to be collected at your home. You should send the ZARA product(s) in its original packaging, if possible, and follow the directions on the "Returns" section of this website. If you have bought any ZARA product(s) as a guest, you may request returns by courier by writing to our contact form. Please be informed that

you will bear the cost of returns by courier; we will charge a fixed amount (regarding the amount we refer to "Returns" section) which we will immediately deduct from the amount to be refunded to you.

# (iii) Returns at collection points:

You may request a return at a collection point in the Czech Republic (post office or packing station). After you have requested the return, you will receive an e-mail and the stamped return slip to print out and stick on the parcel. To request the franked return slip, please follow the instructions under the "Returns" section of "My Account" on this website. If you have bought any ZARA product(s) as a guest, you may request returns at collection points by writing to our contact form. Please be informed that you will bear the cost of returns organized this way; we will charge a fixed amount (regarding the amount we refer to "Returns" section) which we will immediately deduct from the amount to be refunded to you.

Alternatively you can return the ZARA product(s) directly to the following address: Rhenus Logistics S.A., Oddział Poznań II ul. Rabowicka 51B, 62-020 Swarzędz. We ask you to return the product(s) without delay, together with the print-out of the e-ticket that was attached to the Delivery Confirmation, which is also saved under your account on our website, and on the ZARA mobile app. The costs incurred in the return of the product(s) in this way are payable by you.

## - Zara Home products:

Upon withdrawal, you may return all Zara Home product(s) to any ZARA or Zara Home store in the Czech Republic. In such case, you should go to such store and present the product(s) with the e-ticket that was attached to the Delivery Confirmation, which is also saved under your account on our website, and on the mobile app. You can present the e-ticket either by showing it in digital form on your mobile phone, or by bringing to the store a print-out of the e-ticket. This option does not require you to pay additional costs.

You can return the Zara Home product(s) directly to following address, ZARA Home, Sosnowiec 15A, 95-010 Stryków, Poland. We ask you to return the product(s) without delay, together with the print-out of the e-ticket that was attached to the Delivery Confirmation, which is also saved under your account on our website, and on the mobile app. The costs incurred in the return of the product are payable by you.

Please note that, following delivery of the order, if you exercise your statutory or contractual right of withdrawal, you will be responsible for the content of the return package when you use any of the return options stated herein. In the event that there is an error in the content of the return package not attributable to us, we will be entitled to pass on you the corresponding costs if it is possible to manage the return of the package to your attention. In any case, nothing in this clause will affect your statutory rights.

After examining the article, we will inform you of whether you have the right to reimbursement of the amounts paid (less return costs if applicable, please see above or "Returns" section). Delivery charges will be reimbursed when the right of withdrawal is exercised within the statutory period and all relevant product(s) are returned. The refund will be paid as soon as possible and, in all cases, within 14 days from the date on which you notified us of your intention to cancel.

Notwithstanding the foregoing, we may withhold reimbursement until we have received the product(s) back or you have supplied evidence of having sent back the product(s) whichever is the earliest. The refund will always be paid using the same payment means you used to pay for your purchase.

If you have any questions, you can contact us on our contact form.

### **16.4 Change of size** (this feature is only available for ZARA products)

If you decide that the ZARA product(s) that you have purchased is in the wrong size for you, then you may be able to request a change in its size, without having to pay an additional delivery charge for the new product(s) being sent to you provided you return the original product(s). This is regardless of your statutory and contractual rights of withdrawal, which will continue to exist legally and contractually. You can request the change of size via the "Returns" section of "My account" on this website. You should select the new size of your product(s), and provided that (i) it is the same item, (ii) its price on the website is equal to or greater than the price that you paid for the original item (but please note, in this case only, you won't be charged for the price) and (iii) only certain means of payment have been used (please see Clause 12 of these Conditions for further information), then you will be able to request the change in size. Please note that the option for you to change the size of your original product(s) will only be displayed as being available when all of these conditions are met.

Once you have requested the change and selected the appropriate return method, you must return the original product(s), either in any ZARA store in the Czech Republic which has the same section to which the product(s) you wish to change belongs to, or via a courier that we will send to your home. You must return the product(s) without any undue delay, and in any event within a maximum period of 14 calendar days from the change request in the website. Neither of the two options for returning the product(s) will generate (with exception of failed return of the original product(s) regulated in the last paragraph of this Clause) additional costs for you.

If you return the product(s) in any ZARA store in the Czech Republic, which has the same section to which the item you wish to change belongs to, you should present as well as the item, the e-ticket that was attached to the Delivery Confirmation, which is also saved under your Account on our website and on the Zara mobile app; you can present the e-ticket either by showing it in digital form, or by bringing to the store a print of the e-ticket

If you return the product(s) by courier arranged by us, you should, if possible, return it in the same package that you received it, and follow the directions on the "Returns" section on this website.

After you have chosen your return method, we will send the new order with the product(s) in the revised size within 2-3 working days from the date of the request of the change, and in any event within a maximum period of 30 days from that date. This option will not present an extra cost to you. This new order is governed by the provisions of the Terms and Conditions, including the exercise of the right of withdrawal.

Please note that if after 14 calendar days from the change request in the website, you have not returned the original item, we are entitled to charge the costs corresponding to the new order placed, subject to the provisions of the Terms and Conditions.

## 16.5 Returns of defective product(s)

If you think that at the moment of delivery the product(s) is/are not as stipulated in the Contract, you must contact us immediately through the "Returns" section of "My account" on this website or by writing to our contact form, providing the product(s) details and the damage sustained, defects or other inconsistencies.

You must return the **ZARA product(s)** to the address indicated under Clause 16.3, at any ZARA store in the Czech Republic, or request a return at a collection point in the Czech Republic (post office or packing station) the **Zara Home product(s)** to the address indicated under Clause 16. 3 (for returns of Zara Home products) or at any ZARA or Zara Home store in the Czech Republic. In any case, you must return / send the product to be returned together with the e-ticket that was attached to the Delivery Confirmation, which is also saved under your account on our website, and on the mobile app.

We will carefully examine the returned product(s) and will notify you by email within a reasonable period if the product(s) may be exchanged or whether you have a right for a refund (as appropriate). The refunding or replacement of the article(s) shall take place as soon as possible and in all cases within 30 days of your complaint.

If a defect or damage is confirmed on the returned product(s), we will give you a complete refund including the charges you have accrued of delivery and return. The refund will always be paid using the same payment means you used to pay for your purchase.

All rights recognised in current legislation shall be, in any case, safeguarded.

# 16.6 Right of withdrawal and return for orders from abroad

If you have ordered products from outside the Czech Republic from another EU member state via this website, the above clauses 16.1 - 16.4 apply with the restrictions that the collection by a courier commissioned by us can only be made from the original delivery address within the Czech Republic.

At the same time we would like to inform you that we are under no circumstances (with exception of clause 16.5 to which this clause 16.6 does not apply) obliged to pay shipping costs to destinations other than the original delivery address and/or the return costs from destinations outside the Czech Republic.

## 17. LIABILITY AND WAIVING LIABILITY

Nothing in these Conditions shall exclude or limit in any way our liability:

- i. in case of death or personal harm caused by our negligence;
- ii. in case of fraud or fraudulent deceit; or
- iii. in any case in which it were illegal or illicit to exclude, limit or attempt to exclude or limit our liability. Notwithstanding the paragraph above, and to the extent legally allowed, and unless these Conditions indicate otherwise, we shall not accept any liability for the following losses, regardless of their origin:
- i. loss of income or sales;
- ii. operating loss;
- iii. loss of profits or contracts;
- iv. loss of forecast savings;
- v. loss of data; and
- vi. loss of business or management time.

Due to the open nature of this website and the possibility of errors in storage and transmission of digital information, we do not warrant the accuracy and security of the information transmitted or obtained by means of this website, unless otherwise indicated expressly on this website.

All product descriptions, information and materials shown on this website are provided "as is", with no express or implied warranties on the same, except those legally established. In this sense, if you are contracting as a consumer or user, we are obliged to deliver goods that are in conformity with the Contract, being liable to you for any lack of conformity which exists at the time of delivery. It is understood that the goods are in conformity with the Contract if they: (i) comply with the description given by us and possess the qualities that we have presented in this website; (ii) are fit for the purposes for which goods of this kind are normally used; (iii) show the quality and performance which are normal in goods of the same type and which can reasonably be expected. To the extent permitted by law, we exclude all warranties, except those that may not be excluded legitimately in favour of consumers and users.

## Lack of Conformity

If you are contracting as consumer or user, we are liable to you that the product(s) is/are free from defects upon receipt. In particular, we are liable to you that, at the moment the product(s) is/are received by you:

- i. it/they conform(s) to the agreed description, type and quantity, as well as quality, functionality, compatibility, interoperability and other agreed characteristics,
- ii. it/they is/are fit for the purpose for which you require it/they and to which we have agreed, and
- iii. it/they is/are supplied with the agreed accessories and instructions for use, including instructions for assembly or installation.

Unless we have specifically advised you prior to the conclusion of the Contract that a feature of the product(s) is/are different and you have expressly agreed to this when concluding the Contract, we are further liable to the you that, in addition to the agreed characteristics:

- i. the product(s) is/are fit for the purpose for which an item of that kind is normally used, including with regard to the rights of third parties, legislation, technical standards or industry codes of practice, if there are no technical standards,
- ii. the product(s) correspond(s) in quantity, quality and other characteristics, including durability, functionality, compatibility and safety, to the usual characteristics of products of the same kind which the consumer may reasonably expect, including in the light of public statements made by the us or by another person in the same contractual chain, in particular advertising or labelling,
- iii. the product(s) is/are supplied with such accessories, including packaging, assembly instructions and other instructions for use, as the consumer may reasonably expect, and
- iv. the product(s) correspond(s) in quality or workmanship to the sample or specimen provided by us to the you before the conclusion of the Contract.

If the product(s) become(s) defective within one year after receipt, the product(s) is/are deemed being defective already upon receipt. The buyer (consumer) may complain about a defect that becomes apparent within two years of receipt. If the buyer (consumer) has rightly claimed the defect, the two-year period under the previous sentence does not run for the period during which the buyer (consumer) cannot use the product(s). This does not apply to:

- i. Discount related defects;
- ii. Usual wear and tear;
- iii. Defects caused by ordinary use or wear and tear and evident at the moment of receipt by the consumer;
- iv. Cases implied by the nature of the case.

Improper performance cannot be claimed if you were aware of the defect before accepting the product or if the defect in question was caused by you. You are not entitled to claim guarantee with reference to a defect caused by outer circumstances after the risk of damage has passed to you.

# Your Rights Due to Product Defects

If the product(s) has/have a defect, you can demand that the defect be removed. You may, at your option, require (i) replacement of the product or (ii) repair unless the chosen method of remedying the defect is impossible or disproportionately expensive compared to the other method (this will be assessed in particular having regard to the significance of the defect, the value the item would have had without the defect and whether the defect can be remedied by the other method without significant inconvenience to you).

Please note, that we reserve the right to refuse to remove the defect if it is impossible or unreasonably costly to do so, having regard in particular to the significance of the defect and the value the item would have had without the defect.

If the defect is removable and we have not rejected this method of dealing with your complaint, we will remove the defect within a reasonable time after your complaint so as not to cause you significant inconvenience. In any event we will remove the defect and notify you of this within 30 days of your complaint, unless you agreed to an extension of time for removal of the defect at the time of your complaint.

When claiming the defect in question, please inform us as to which of the aforementioned two options you have selected as the selected option can be then changed only if so approved by us; with the exception of a defect requested by you to be repaired and subsequently being identified as irreparable. If the defects are not removed by us within 30 days, unless you agreed to an extension, or if we informed you that the defects in question will not be removed, you may claim a reasonable discount on the purchase price or withdraw from the Contract to receive from us full refund of that what you have paid for the product(s).

You may also demand a reasonable discount or withdraw from the Contract if (i) the defect appears repeatedly or (ii) the defect forms a material breach of Contract. A reasonable discount shall be determined as difference between the value of the non-defective item and the defective item received.

Please note, that under the law you are not entitled to withdraw from the Contract if the defect in the product is insignificant.

For details on returning goods and refunding what you have paid us please refer to clause 16.5 above.

## <u>Gift</u>

The consumer acknowledges that if the goods are delivered along with any gift, the Seller and the consumer enter into a contract of donation on the resolutive condition that such contract of donation terminates as soon as the consumer enjoys its right and withdraws from the purchase Contract whereby

the consumer must return the goods in question along with the gift(s) and everything obtained in relation thereto; if not returned, the same will be considered unjust enrichment. If the profits acquired by unjust enrichment cannot be returned, the Seller may and can claim monetary compensation in the amount of ordinary price.

We will report any failure to comply with this regulation to the corresponding authorities and we will co-operate with them to determine the identity of the attacker/hacker. Likewise, in the event of failure to comply with this clause, authorisation to use this website shall be suspended immediately.

We shall not be held liable for any damage or harm resulting from a denial of service attack, virus or any other software or technologically damaging or harmful material that may affect your computer, IT equipment, data or materials as a result of using this website/App or downloading content from the same or those to which this website/App redirects you.

## 20. LINKS FROM OUR WEBSITE

Accordingly, we shall not accept any liability for any damage or harm deriving from their use.

### 21. WRITTEN COMMUNICATION

The applicable regulations require that some of the information or notifications that we send to you be in written form. By using this website, you agree that most of the communication with us will be electronic. We will contact you by email or we will provide you information by posting alerts on this website. For contractual purposes, you agree to use this electronic means of communication and accept that all contracts, notifications, information and other communication that we send you electronically complies with the legal requirements of providing it in writing. This condition will not affect your statutory rights.

### 22. NOTIFICATIONS

The notifications that you send us must be sent preferably through our contact form. Pursuant to the provisions in Clause 21 above and unless otherwise stipulated, we may send you notifications either by email or to the postal address you provided us when placing an order.

It is understood that notifications will be received and acted upon as soon as they are posted on our website, 24 hours after they have been sent by email or three days after the postage date on any letter. As proof that the notification has been sent it shall be sufficient to prove, in the case of a letter, that it was correctly addressed, that the correct postage was paid and that it was duly delivered to the post office or to a mail box; in the case of an email, that the notification was sent to the email address specified by the recipient.

### 23. TRANSFER OF RIGHTS AND OBLIGATIONS

The Contract is binding for both Parties, as well as for our respective successors, transferees and heirs. The registered user is not entitled to allow the use of his/her "My Account" to third parties.

We may transmit, cede, levy, subcontract or in any other way transfer a Contract or any of the rights or obligations derived from the same, at any time during the life of the Contract. To avoid any doubt, said transmissions, cessions, levies or other transfers shall not affect the rights that, as applicable, you have as a consumer recognised by law or cancel, reduce or limit in any way the express and tacit warranties that we may have given you.

## 24. EVENTS BEYOND OUR CONTROL

We will not be liable for any non-compliance or delay in compliance with any of the obligations we assume under a Contract when caused by events that are beyond our reasonable control ("Force Majeure").

Force Majeure shall include any act, event, failure to exercise, omission or accident that is beyond our reasonable control, including, among others, the following:

- i. Strike, lockout or other forms of protest.
- ii. Civil unrest, revolt, invasion, terrorist attack or terrorist threat, war (declared or not) or threat or preparation for war.
- iii. Fire, explosion, storm, flood, earthquake, collapse, epidemic or any other natural disaster.
- iv. Inability to use trains, ships, aircraft, motorized transport or other means of transport, public or private.
- v. Inability to use public or private telecommunication systems.
- vi. Acts, decrees, legislation, regulations or restrictions of any government or public authority.
- vii. Strike, failure or accident in maritime or river transport, postal transport or any other type of transport.

It shall be understood that our obligations deriving from Contracts are suspended during the period in which Force Majeure remains in effect and we will be given an extension of the period in which to fulfil these obligations by an amount of time equal to the time that the situation of Force Majeure lasted. We will provide all reasonable resources to end the situation of Force Majeure or to find a solution that enables us to fulfil our obligations by virtue of the Contract despite the situation of Force Majeure.

#### **25. WAIVING RIGHTS**

The lack of requirement on our part for strict compliance on your part with any of the obligations assumed by you by virtue of a Contract or of these Conditions or a lack of exercising on our part of the rights or actions that correspond to us by virtue of this Contract or of the Conditions shall not constitute the waiving or limitation of said rights or actions, nor exonerate you from fulfilling said obligations.

The waiving on our part of a specific right or action shall not constitute the waiving of other rights or actions derived from the Contract or from the Conditions.

The waiving on our part of any of these Conditions or of the rights or actions derived from the Contract shall not take effect unless expressly stipulated that it is a waiving of rights and is formalised and notified to you in accordance with the provisions of the Notifications section above.

#### **26. PARTIAL ANNULMENT**

Should any of these Conditions or any provision of a Contract be declared null and void by firm resolution from the corresponding authority, the remaining terms and conditions shall remain in effect without being affected by said declaration of annulment.

## **27. ENTIRE CONTRACT**

These Conditions and any document referenced in the same constitute the Entire Contract between the Parties as regards the purpose of the same, replacing any previous pact, agreement or promise made between the Parties verbally or in writing.

The Parties acknowledge that we have agreed to enter into the Contract without depending on any declaration or promise made by the other Party or that could have been inferred from any statement or document in the negotiations entered into by the two Parties prior to said Contract, except those expressly mentioned in these Conditions.

Neither Party shall take any action regarding any untrue statement made by the other Party, verbally or in writing, prior to the date of the Contract (unless said untrue statement was made fraudulently). The only action that may be taken by the other Party shall be due to breach of contract in accordance with the provisions of these Conditions.

## 28. OUR RIGHT TO MODIFY THESE CONDITIONS

We have the right to review and modify these Conditions at any time. The changes and modifications shall take effect on the day of their publication on the website www.zara.com. If you do not agree to the changed and modified Conditions, you are entitled to cancel your account, otherwise we will assume that you agree with them.

You are subject to the policies and Conditions in effect at the moment in which you use this website or place each order, except when by law or decision of governmental entities we must make changes retroactively to said policies, Conditions or Privacy Policy. In this case the possible changes will also affect orders made previously by you.

The Seller is entitled to sell goods on the basis of the trade license. A trade control is carried out under authority of the respective Trade Licensing Office.

If you are entering into the contract as a consumer, nothing in this clause shall affect the statutory rights you have, as recognised in any applicable legislation in this area.
