- 1. Use of this Gift Card constitutes your acceptance of these terms and conditions.
- 2. The Card is exclusively valid in Hong Kong SAR (Hong Kong) to purchase products being sold in any ZARA store or via www.zara.com.
- 3. The Card may be purchased by any of the means of payment accepted at the ZARA stores or via www.zara.com. The Card shall not be paid for by means of another Gift Card. The sale of the different card formats shall be subject to their availability in Hong Kong.
- 4. Once bought, the balance of the Card shall not be refunded or exchanged for cash.
