

ZARA GIFT CARD
GENERAL TERMS AND CONDITIONS OF USE

1. The Gift Card (hereinafter, the Card) is the property of the issuer ZARA PUERTO RICO, INC. (hereinafter, ZARA). The holder of the Card being a mere depository.
 2. The Card is exclusively valid in Puerto Rico to purchase products being sold in any ZARA store or via www.zara.com.
 3. The price of the Card can be paid by any of the means of payment accepted at the ZARA stores or via www.zara.com.
 4. The Card is rechargeable, but any outstanding balance of the Card may not be refunded or exchanged for cash, except as required by law. The return of any Card that has not been used yet (as used in this Policy, "used" refers to making a purchase with the Card and/or recharging it) shall be accepted within the following terms, and always in observance of the statutory term provided:
 - 4.1 Cards purchased at any ZARA store may be returned within 30 calendar days as of the date of purchase.
 - 4.2 Physical Cards purchased via www.zara.com may be returned within 30 calendar days as of the date of the shipping confirmation e-mail.
 - 4.3 Virtual Cards purchased via www.zara.com may be returned within 30 calendar days as of the date of dispatch of the virtual Card by ZARA to the intended recipient thereof.
- Sale of these different card formats shall be subject to their availability in Puerto Rico.
- If you elect to return an unused Card as permitted pursuant to the terms herein, the price paid for the Card shall be refunded using the same means of payment used to purchase it. For such refund, the original sales receipt or e-ticket and, where appropriate, the original card used for payment and the payment receipt must be presented. Return of any Card purchased abroad or at any www.zara.com website of any other country shall not be accepted.
5. The Card can be used as often as the holder thereof would like, until the total amount has been used up.
 6. The remaining balance on the Card shall be the difference between the remaining balance available prior to the purchase, and the relevant amount used up in such purchase(s). Where the purchase price is in excess of the remaining balance on the Card, the difference may be paid through any payment means accepted at ZARA stores or at www.zara.com, as the case may be.
 7. For purchases made at any ZARA store, the remaining balance on the Card is shown on the cash register receipt every time a purchase is made with the Card; for purchases made via www.zara.com, the remaining balance on the card is shown in the information provided upon placing an order. The remaining balance of the Card may be checked at any ZARA store or at www.zara.com.

8. Products purchased with the Card at any ZARA store shall be subject to the general purchase terms and conditions as any other products purchased at said stores. Products purchased with the Card via www.zara.com shall be subject to the purchase terms and conditions shown on said website.
9. In accordance with paragraph 8 above, where appropriate, refunds for products purchased with the Card but that are returned shall be made by ZARA by crediting the price of the returned product back onto the remaining balance of the Card. However, where the Card no longer exists upon return of the products, the price of such product shall be credited to a Voucher Card.

Refund methods hereunder provided are an essential term, and as such, they are deemed to be expressly accepted upon purchasing and/or using the Card.

10. The Card does not have an expiration date and shall remain valid until all value stored on the Card is used.
11. The Card is a bearer instrument. Its holder shall be solely responsible for the use and custody of the Card. The Card shall not be replaced in case of theft, loss or damage thereof. However, ZARA may replace the Card in case of change of format of the Card.
12. Where the virtual Card is purchased via www.zara.com, ZARA shall not be responsible for the non receipt or the delay in receiving such Card by its intended recipient on grounds beyond ZARA's control, including inter alia: (i) the deficiencies or the breakdown of telecommunications lines/systems, (ii) the delay in the transmission of information or data or the loss of information or data which may occur under any of the circumstances provided under letter (i) above; (iii) the inaccuracy of the details of the recipient of the virtual Card provided by the purchaser of the Card; (iv) the non delivery of the Card at the e-mail address provided, or (v) the fact that the e-mail sent by ZARA is deemed to be spam or unwanted e-mail.
13. Cards originally obtained through any unlawful means shall be null and void and they may not be used to purchase products, nor shall the price thereof be refunded.
14. The Card may not be used for the purposes of advertising or promoting products or services marketed by any third party other than the issuer of the Card, unless express prior written consent is given by this ZARA.
15. The purchase and/or use of the Card entails the full acceptance of these terms and conditions, which have been made available to the customer upon purchase of the Card, and which are also available at any ZARA store and at www.zara.com.
