GIFT CARD GENERAL TERMS AND CONDITIONS

- 1. The Gift Card (hereinafter the Card) is exclusively valid to purchase products being sold in any brick-and-mortar store and online on any website of the Inditex Group in Slovakia, this includes: Zara, Pull&Bear, Massimo Dutti, Bershka, Stradivarius, Oysho and Zara Home (hereinafter, individually any of them, Store, and collectively, Stores); if a card refers to only one of these Inditex Group brands on its surface, this does not limit its usability.
- 2. The Card is the property of the issuer: Inditex Slovakia, s. r. o., VAT N° SK 2022395078, registered office at Einsteinova 18, 851 01 Bratislava, email address: office@cz.inditex.com and phone number (for identification purposes only) +420 224 239 873 (hereinafter Inditex SK). The holder of the Card is a mere user and depositary thereof.
- 3. The price of the Card can be paid by any of the means of payment, depending on the place (brick and mortar store or online on any website) where the Card was acquired.
- 4. The return (right of withdrawal) of any Card which has not been used yet, shall be accepted (even without stating a reason), exclusively at the Store where it was purchased, within the following terms, and always in observance of the statutory term provided:
 - 4.1 Physical Cards, within thirty (30) calendar days as of the date of purchase, for Cards purchased at brick-and-mortar stores, and as of the shipping confirmation email, for Cards purchased online.
 - 4.2 Virtual Cards, within thirty (30) calendar days as of the date of dispatch of the Card to the intended recipient thereof.

Sale of these different card formats shall be subject to their availability in Slovakia.

The price paid for such Card shall be refunded using the same means of payment used to purchase it. For such refund, the original till receipt or e-ticket and, where appropriate, the payment card and the payment receipt must be produced. Return of any Card purchased abroad or at any website of any other country shall not be accepted.

Please note that by using the Card within the right of withdrawal period of 30 calendar days as stipulated above you lose your right of withdrawal.

- 5. Any outstanding balance of the Card shall not be refunded or exchanged for cash.
- 6. The Card can be used as often as the holder thereof would like, until the total amount (equivalent to the price of the Card) has been used up. The remaining balance available shall be the difference between the remaining balance available prior to the purchase and the relevant amount used up in such purchase; where the purchase price is in excess of the remaining balance, the difference may be paid through any payment means accepted.
- 7. The remaining balance on the Card is shown on the till receipt every time a purchase is made with the Card, for purchases made at any brick-and-mortar store, or in the information provided upon placing an order, for purchases made online. The remaining balance of the Card and the day of expiry may be checked at any Store.
- 8. Products purchased with the Card at any brick-and-mortar store shall be subject to the same exchange and return policy as well as to statutory rights as any other products

purchased at said stores. Products purchased with the Card online shall be subject to the purchase terms and conditions shown on the relevant websites of the Inditex Group.

9. Where appropriate, any refund of the price of products purchased with the Card which are returned shall be made by crediting the price of the products back onto the remaining balance of the Card. However, if the Card no longer exists upon returning the products, the price of the products shall be credited to a Voucher Card, whose terms and conditions of use are: Voucher cards shall be valid to purchase any product being sold in the Stores for a 3-year period from its date of delivery. Its outstanding balance shall not be refunded or exchanged for cash. Lost, stolen or damaged Voucher Cards shall not be replaced.

The refund method herein provided is an essential term. By purchasing and/ or using the Card, this evidences your full acceptance of such term.

- 10. The Physical Card purchased at brick-and-mortar stores is valid for 3 years from the date of purchase, the Physical Card bought online is valid for 3 years from the date of the shipping confirmation e-mail thereof and the Virtual Card is valid from the date of dispatch to the intended recipient thereof. At the expiry of the validity period, the Card cannot be renewed, or used to purchase products, nor shall any unused remaining balance in the Card be claimed.
- 11. The Card is a bearer instrument. Its holder shall be solely responsible for the use and custody of the Card. The Card shall not be replaced in case of theft, loss or damage there-of. However, Inditex SK may replace the Card in case of change of format of the Card.
- 12. Cards originally obtained via any unlawful means shall be null and void and they shall not be used to purchase products, nor shall the price thereof be refunded.
- 13. Where a Virtual Card is purchased, Inditex SK shall not be responsible for the non-receipt or the delay in receiving such Card by its intended recipient on grounds beyond Inditex SK's control, including inter alia: (i) the deficiencies or the breakdown of telecommunications lines/systems, (ii) the delay in the transmission of information or data or the loss of information or data which may occur under any of the circumstances provided under letter (i) above; (iii) the inaccuracy of the details of the recipient of the Virtual Card provided by the purchaser of the Card; (iv) impossibility of delivery of the Card at the e-mail address provided, or (v) the fact that the e-mail sent is deemed to be spam or unwanted e-mail.
- 14. The Card shall not be used for the purposes of advertising or promoting products or services marketed by any third party unless prior written consent is given by the issuer.
- 15. The purchase and/or use of the Card entails the full acceptance of these terms and conditions, which are made available to the customers upon purchase of the Card, and which are also available at the Stores. In respect of Cards issued before the issuance of these terms and conditions which at the time of their issuance were expected to be used only for one of the brands listed in point 1, the use of the Card for a different brand than the one for which it was issued entails full acceptance of these terms and conditions, which replace the original terms and conditions of use of the Card; this applies to Voucher Cards as well.
- 16. Complaints which arise out of the use of this Card shall be addressed to Inditex Slovakia, s. r. o., Einsteinova 18, 851 01 Bratislava or made orally in the Store in which it was purchased. If you are not happy with how we dealt with your complaint, you may seek a remedy with a written request addressed to Inditex SK; if we reject your request or do not respond within a period of 30 days as of sending you are entitled to submit a motion for the commencement of proceedings of alternative dispute resolution according to the

Article 12 of the Act No. 391/2015 Coll. on Alternative Consumer's Dispute Resolution as amended. The respective subject to solve the dispute is Slovak Trade Inspection, with its registered seat at Bajkalská 21/A, P. O. BOX č. 5, 820 07 Bratislava (http://www.soi.sk) or any other authorized subject registered with the list of the subject of the alternative dispute resolutions held by the Ministry of Economy of the Slovak Republic (http://www.mhsr.sk).
